ENTRY DETAILS

Exhibitors may nominate entries for a number of animals not exceeding 150% of the spaces booked. Details of all animals nominated and class numbers must be shown on the entry. Please note that the number of spaces booked is to represent the actual number of animals being brought to the Show.

Exhibitors shall not bring onto the Showground any more animals than spaces booked.

Exhibitors who do not fill all their spaces with cattle will be fined in accordance with the following scale:

- 1 space - \$20 per space
- 2 spaces - \$40 per space
- 3 spaces - \$60 per space
- 4 spaces - \$80 per space
- 5 or more spaces - \$100 per space

All exhibits will be catalogued in age order.

Any fine issued must be paid before exhibitors are permitted to show their animal/s. The Committee reserves the right to re-allocate any space/s not occupied by an exhibit.

SUBMISSION OF ANIMALS ENTERED

There is no restriction on the number of animals per exhibitor in each class.

Should the number of animals entered exceed the number which can be accommodated, the Society reserves the right to reduce the number in whatever manner it deems fit.

CLOSING DATE OF ENTRIES

FRIDAY 19 JULY 2024 at 5.00 pm

The following conditions will strictly apply:

- All entries must be submitted online by the above closing date

Absolutely no exception to the above conditions will be made to any exhibitor under any circumstance.

WITHDRAWALS

All withdrawals must be submitted by 12 August 2024.

All withdrawals must be made in writing and can be sent via email to entries@adelaideshowground.com.au . Verbal withdrawals will not be accepted.

REFUNDS

No refunds of entry fees will be made after the closing date of entries.

OWNERSHIP

All exhibits must be the bona fide property of the exhibitor or held by the exhibitor under a written and recorded lease at time of entry.

All cattle will be NLIS scanned while at the Show.

COMPULSORY REGISTRATION OF STOCK

All cattle must be registered in the Stud Book for its particular breed.

Entries for Appendix 1 and 2 animals will be accepted in the Guernsey and Holstein sections only.

In the Illawarra section, animals that are the progeny of a sire and a dam that are both registered in the Illawarra Herd Book and also comply with the Federal Illawarra Show Policy are eligible to be shown.

“Pending” registrations will not be accepted.

All Dairy Cattle exhibitors must bring the original or a copy of the registration certificate or lease agreement for all animals entered to the Showground. These must be available for perusal at the time of inspection.

Digital or paper copies of registrations will be accepted.

TRANSFER

Please ensure exhibits are entered in the correct class at the time of entry.

INTERSTATE STOCK CLEARANCES

Interstate exhibitors need to complete a National Cattle Health Statement including their dairy score that travels with the cattle and must be presented at the Dairy Office when the cattle are unloaded. The form can be downloaded from:

NLIS REQUIREMENTS

All cattle must be NLIS compliant. This means all animals must be tagged with an approved NLIS ear tag (including calves at foot). The Society will notify the NLIS database of all movements onto the Showground on behalf of exhibitors.

In relation to your entry into a competition we may specifically use and/or disclose your personal information to:

- Communicate competition information to you such as entry opening dates, delivery and collection details and entry ticket distribution
- Publish competition results both online and in printed results listings
- Publish competition entries in Competition Catalogues
- Advise sponsors of competition prize winners for distribution of prizes from both the RA&HS and sponsors

By entering into a competition, you consent to your contact details being provided to the sponsors of that competition for the purpose of distributing your prize. You also consent to your name, suburb and postcode being listed in a competition catalogue and, if you are a prize winner your name in competition results.

If you do not wish for your name and address to be printed in a competition catalogue, please ensure that you select the 'Keep Private' option in your online exhibitor profile.

PRIZES AND AWARDS

Prize money will be paid as follows:

Dry Classes

First \$80; Second \$40; Third \$30; Fourth \$15

In Milk Classes

First \$120; Second \$60; Third \$45; Fourth \$20

Group Classes (including Type & Production and all classes where animal is drawn from general classes)

First \$40; Second \$30; Third \$10

First to fourth prize ribbons will be available in all classes.

If there is prize money allocated for 5th and/or 6th, a ribbon will also be presented.

In Feature Breed classes, judges may award to 6th position regardless of the number of entries.

Sashes will be awarded to all Champions, Reserve Champion, Supreme Champion and Most Successful Exhibitors, Cow with Best Udder, Type and Production Classes, and Production Ribbons Classes

SPECIAL PRODUCTION RIBBON

A special production ribbon will be awarded to the top butterfat plus protein production entry, from the ribbon winners, in each of the female classes 3 years old and over.

The production calculation will be taken from the production certificate provided by the exhibitor of that animal. The most recently completed 305 day or less lactation will be used in the first instance. If the animal has not reached 305 days in her current lactation at the time of the show or completed a lactation, then her previous lactation will be used providing it was completed or 305 days was reached after July 1st of the previous year. In all cases the lactations used must only be a maximum of 305 days.

MOST SUCCESSFUL EXHIBITOR AWARDS

In determining the most successful awards, points will be allotted as follows:

First, 3 points; second, 2 points; third, 1 point.

In the event of a tie the following extra points will be counted:

Senior Champion, 3 points; Intermediate Champion, 3 points; Juvenile Champion, 2 points; Reserve Senior Champion, 2 points;

Reserve Intermediate Champion, 2 points; Reserve Juvenile Champion, 1 point.

If there is still a tie, then fourth, fifth and sixth prizes will be taken into account.

Excluding Group Classes

PAYMENT OF PRIZE MONEY

All prize money won during the Royal Adelaide Show will be paid by Electronic Funds Transfer (EFT) only.

PRIZE MONEY WILL BE PAID BY THE END OF OCTOBER.

Any trophy, prize or prize money not claimed by 11 December of the current year, shall be deemed forfeited by the exhibitor and the RA&HS shall no longer be liable to pay or provide the prize.

PRIZE MONEY AND GST

Prize money as stated in the Prize Schedule does not include GST.

The prize money which we pay to successful exhibitors depends on information provided to us. If you confirm that you are GST registered and provide your Australian Business Number (ABN), we will pay the appropriate prize money plus 10% GST. We will provide you with a Recipient Created Tax Invoice which you will need to submit to the Australian Taxation Office.

If you confirm you are registered for GST, in entering the competition, you acknowledge your agreement to the following:

- You will not issue a tax invoice to the RA&HS in respect to prize money received
- You will notify the RA&HS if you cease to be registered for GST

If you provide your Australian Business Number but are not registered for GST, we will pay the prize money as detailed in the Prize Schedule without reference to the GST.

If you confirm you are entering as part of a private recreational pursuit or hobby, we will pay the prize money as detailed in the Prize Schedule without reference to GST.

IMPORTANT

It is important that you either:

- Confirm you are entering as part of a private recreational pursuit or hobby, or
- Confirm you are entering as a GST registered business and supply your ABN

Failure to do either of the above will cause the RA&HS to withhold tax, at the maximum tax rate, from your prize money in accordance with Australian tax legislation.

The RA&HS is not a tax consultant and therefore assumes no liability for actions taken as a result of these guidelines. In any instances where an entrant or sponsor is uncertain of the tax implications of their involvement, they should consult their own accountant or tax advisor.

The Society makes every endeavour to ensure all prizes listed are accurate at the time of publishing. Should a cash prize be withdrawn by a sponsor subsequent to publishing, the prize will revert back to the competitions default amount where applicable. Vouchers, product or trophies withdrawn by a sponsor subsequent to publishing will not be replaced. It is the responsibility of the prize winner to follow-up with the Society any sponsored prize (cash, voucher, product, trophy) they believe they are entitled to prior to 30 November in the year of the prize being awarded. The Society will not follow-up prize sponsors after this date or review any prizes that may have been incorrectly awarded.

GENERAL REGULATIONS

Exhibitors are reminded that the Society's General Regulations apply to all sections of the Show. A copy of the General Regulations can be obtained from the Society's website at www.theshow.com.au or from the Society's Administration Office.

Exhibitors should note that the General Regulations contain a number of provisions relevant to competitions and this Schedule including but not limited to, offences, penalties, prohibited drugs. As those conditions apply in addition to the regulations contained within this schedule. Exhibitors should familiarise themselves with the General Regulations.

SPECIAL REGULATIONS

Exhibitors are reminded that the Special Regulations contained within this Schedule are merely supplementary to and subject to the General Regulations.

The members of the Society's Dairy Cattle & Pig Committee shall have the authority to act on behalf of the Society to take any necessary action under these Special Regulations.

GENERAL INFORMATION

ENTRY GATE

All cattle to be unloaded at Leader Street No 3 Car Park – NO UNLOADING OF CATTLE ON THE SHOWGROUND.

Cattle will not be admitted to the Showground before 8.00 am on Thursday 29 August. If exhibitors are arriving outside of these times, they should contact the Dairy Cattle office or a member of the Dairy Cattle Committee.

All cattle must be on the Showground by 12noon on Saturday 31 August. (Excluding School Heifer exhibitors)

INSPECTION OF CATTLE

An inspection will be made of all cattle exhibits for identification purposes and defects. Exhibitors of all cattle shall produce registration certificates of animals entered.

This will take place in the cattle stalls and an attendant must be present to supply any information required by the inspectors. Any animal rejected as a result of this inspection cannot be shown and must be removed from the Showground, the time of removal to be at the discretion of the Committee.

ENTRY PASSES

Exhibitors will receive one Full Show Pass up to five spaces booked (to a maximum of 5 passes)

DUTY OF CARE

It is important to ensure your own safety and that of all other site personnel, visitors and general public at the Adelaide Showground.

All competitors have a "Duty of Care" to avoid exposing themselves or other people to situation which could lead to injury. This "Duty of Care" extends to the prevention of damage to property.

DEFINITION OF BREEDER

The breeder of an animal is the registered owner of its dam at the time of birth, excepting in the Holstein-Friesian section in which case the Holstein-Friesian Cattle Association definition will apply.

CLIPPING CHUTES

Exhibitors wishing to use an area to clip their animal/s must apply for a clipping chute at the time of entry. If you are using a professional fitter on your cattle, please ensure a clipping chute space is booked. Clipping chutes will not be permitted to be placed in spaces booked for animals. Clipping chutes placed in spaces allocated to animals will be removed.

CLIPPING OF EXHIBITS

Exhibitors shall not clip Dairy Cattle on the Showground between 10.00 pm and 5.30 am. Exhibitors who clip animals outside of these times will not be permitted to parade for judging.

LOCKERS

A limited number of lockers are available on the Showground. The Society will, subject to availability, allocate lockers to exhibitors.

Applications for lockers must be made at the time of entry.

Lockers will (subject to demand) be allotted on the following basis:

Exhibitors under 15 years of age may not apply for a locker

Exhibitors with less than eight spaces can apply for one locker only.

Exhibitors with 1 to 2 spaces may be allocated a share locker

Exhibitors with eight or more spaces can apply for two lockers only.

Due to the limited number of lockers available for exhibitors onsite, we urge exhibitors to consider their accommodation requirements and plan accordingly.

The use of cooking or heating apparatus in lockers is strictly prohibited. The consumption of intoxicating liquor or drugs in lockers is forbidden.

The consumption of intoxicating liquor in all pavilions, halls and attendants' lockers is forbidden.

Schools will receive a complimentary locker for storage only.

SHOW ETHICS

The Dairy Section of the RA&HS subscribes fully to the National Code of Ethics devised by the All Dairy Breeds Show Ring Committee (ADBSRC). The ADBSRC consists of representatives of all Australian Dairy Breeds and has the primary purpose of developing a national code of show ring ethics to ensure dairy animals presented for exhibition will be in their natural conformation and structure, free from modification caused by unethical fitting practices. Details of the Code of Ethics are fully described in the document All Dairy Breeds National Show Ring Code of Ethics - Dated October 2021. It is the responsibility of all exhibitors to read and familiarise themselves with the Code of Ethics regulations. They are available from the RA&HS website under the Dairy Cattle Competition Information. It is the Exhibitors responsibility to ensure that any animal in their ownership or their representatives, associated with the preparation and exhibition of their animal is not subject to any violation of the Code of Ethics prior to or during exhibition and whilst on the Adelaide Showground.

The following regulations will be particularly highlighted for the 2024 Royal Show.

All in milk entries will be subjected to an ultra sound udder scan prior to the cow entering the ring for the individual breed class and will not be permitted to return to the Pavilion after scanning, for the purpose of detecting any unethical manipulation of the udder or improper fitting practices, such as over filling and over bagging of cows udders. Any cow found to be showing high levels of stress, must be milked out immediately and will be disqualified from the ring.

Scanning receipt to be presented to the steward upon entering the ring.

All animals may be subject to measuring of top line hair. This will be done randomly as cattle enter the judging ring and top line hair shall not exceed 3.8 cm in height.

Teat Setting is a breach of the rules and regulations and any offending animal detected as a first offence is to be withdrawn immediately from all eligible classes in that current Royal Adelaide Show.

A second breach at the current Show or subsequent Shows by the exhibitor of the teat setting rules would result in the offending animal being withdrawn immediately from all eligible classes at the current Show and the exhibitor then banned from showing any animals at the Royal Adelaide Show the following year.

A third breach at the current Show or subsequent Shows by the exhibitor would then see the exhibitor banned from the Royal Adelaide Show for five years.

STOCK TRUCK PARKING

An area is available at the Morphettville Racecourse for the parking of stock trucks during the Royal Adelaide Show. For further information contact the Entries Team on (08) 8210 5211 or entries@adelaideshowground.com.au

No trucks will be permitted to park on the Showground.

FIRE PRECAUTIONS

Precautions will be taken to guard against fire, and to protect the property at the Show, but exhibits will not be insured at the cost of the Society.

Smoking is only permitted in designated smoking areas.

No exhibitor or other person shall remove, or displace, or interfere in any way with, or use for any purpose other than the prevention of fire, any article or appliance provided for use in the case of an outbreak of fire upon the Showground, nor shall any exhibitor or other person remove or alter, or add to, or interfere in any way with any fixture, fitting, article, appliance or thing owned by the Society, or used in such fixture, fitting, article, appliance or thing for any purpose other than for which it is intended by the Society to be used.

Hay will not be permitted to be stored on top of the lofts directly under the lockers in the Brick Shed.

There is to be no doubling up of power board (i.e.) one power board per power point. Power board size is limited to a maximum of 5 outlets and power boards must be overload protected.

Exhibitors must not store flammable items on the lofts under lockers.

IMPORTANT INFORMATION

Exhibitors are advised that no soft furnishings are to be brought into the Dairy Cattle Pavilions (e.g. lounge chairs etc.) excluding bedding.

PARADES

Exhibitors shall be liable to a fine of \$5 in each case in which the order, of the Committee, to parade is not obeyed, and shall be liable to forfeit any prize awarded to their exhibit or exhibits.

Exhibits participating in a parade must be handled and/or controlled by a competent handler. Handlers participating in Grand Parades must be neatly dressed. Those not appropriately dressed will be asked not to participate. Children under the age of 8 years of age are not to be present in Grand Parades.

EXHIBITS

Cattle must not be rugged during the time the Show is open to the public.

Cattle which are not thoroughly tractable to lead will not be allowed on the Showground.

Any cow or heifer entered as dry, if in milk at time of competition, may compete as a wet cow, or vice versa.

A dry cow is one that has been in milk for nine months or more, and has been milked out immediately before entering the judging ring, or a cow not giving any milk, visibly in calf. This cow must have produced a calf by natural birth within 18 months of the closing date of entries.

WATER CONTAINERS

A small number of watering troughs are available in the wash bay however, exhibitors not wishing to use these troughs are requested to provide their own watering containers.

FODDER

Exhibitors must arrange their own fodder requirements.

The Fodder Store is located on the Showground at the western end of the Tin Dairy. All sales will be by credit card only.

Any exhibitor who, in the opinion of the Committee, has more fodder than is considered necessary, will be required to remove the excess from the Showground.

Exhibitors must not solicit orders for fodder on the Showground.

Large and small square bales of hay and small round bales of hay (not exceeding 1m in diameter) will be permitted to be brought onto the Showground and must be kept tidy. Exhibitors not meeting these requirements will be banned from bringing large square or small round bales onto the Showground at future Shows.

STALL SPACE

The depth of each stall space will be 2.8 metres.

All boards to be positioned no further than 2.8 metres out from the walls. All equipment, including feed and wheelbarrows, are to be stored within the 2.8 metres. Clipping chutes must be placed in the area allocated.

STALL CLEANING

Exhibitors will, to the satisfaction of the Society:

1. Keep the area allotted to them and their animals in a clean and proper condition throughout the Show.
2. Clean their area regularly. Refuse must be deposited in the bins provided.
3. Manure must not be deposited in the alleyways or general purpose rubbish bins.
4. General purpose rubbish must not be deposited in manure bins.
5. To assist in the transfer of manure to the bins provided, please bring own equipment.
6. Exhibitors using calving pens are required to clean them out after use and to dispose of all afterbirth when animals have calved. Afterbirth should be disposed of with sawdust and manure.

DRESS CODE

Exhibitors and/or attendants shall wear attire acceptable to their breed societies when leading cattle in the judging ring and in parades. No exhibitor, or his attendant shall parade stock before the Judge whilst wearing attire bearing his own or the name of the Stud for which he works.

All exhibitors and their assistants/helpers are encouraged to present themselves and their allocated area (including kitchens) in a professional and presentable manner appropriate for a Royal Show.

EXHIBITORS' CARDS

No exhibitor shall display any prize card or prize ribbon on their animal/s or pen/s other than those issued or approved of by the Society for the current Show. Exhibitors can supply their own display cards which show the animals catalogue number, name of exhibit, date of birth, name of sire and dam, name of exhibitor and production. Display cards are also available from the Society.

DOGS NOT ALLOWED

Dogs will not be permitted in the Dairy Cattle area.

ANIMAL HEALTH

INFECTIOUS/NOTIFIABLE DISEASES

Exhibitors must certify their animals brought onto the Showground for competition have not been exposed to any infectious/notifiable disease/s to the best of their knowledge.

SICK OR DISEASED ANIMALS

If, in the opinion of a qualified veterinary surgeon appointed by the Society, an animal on the Showground shall be so injured or be so affected by sickness, disease or other ailment as to warrant its destruction or its removal from the Showground as the case may be the Society shall be entitled to have the animal destroyed and/or require the animal to be forthwith removed from the Showground.

The exhibitor, upon receipt of such notice, shall forthwith remove such animal and failing such removal by them within the time prescribed by the Society, by written notice to the exhibitor or his representative on the Showground, the Society may remove the animal or cause the animal to be removed and all costs and expenses of removal shall be borne by the exhibitor and shall be refunded to the Society.

Each such animal shall at all times be the sole risk and responsibility of the exhibitor and the person or persons removing the animal shall at all times be deemed to be the agents of the exhibitor and all acts and omissions on the part of such person or persons shall be deemed to be the acts and omissions of the exhibitor who shall indemnify and hold indemnified the Society, its servants and agents from all claims whatsoever in respect of the animal whether by reason of any loss or injury to or caused by the animal or because of transportation, feeding or housing or otherwise howsoever.

The pavilion supervisor must be advised immediately of any sick or diseased animals attended to by the Society's Veterinary Surgeon.

JOHNE'S DISEASE

Dairy Cattle attending the Show must be a minimum of Dairy Score 3. Dairy Cattle with a Dairy Assurance Score lower than 7 and over 2 years of age must have had a negative JD blood test. Please return your completed "National Cattle Health Declaration" (together with results if required) with your entry forms. You can obtain this form [here](#).

RINGWORM

1. Any animal found infected with ringworm prior to the Royal Show can still be brought to the Showground provided that a veterinary certificate is produced on arrival stating that the veterinarian has seen the animal treated and/or washed in the last 4 days with an appropriate fungicide.
2. That further washings take place not more than 4 days apart while on the Showground and in the presence of the duty veterinarian.
3. Cattle found infected for the first time while on the Showground - invoke Rule 2.
4. That Breed Societies inspectors reserve the right to ban any animals from the judging ring if an attack is so bad that, in their opinion, the showing of that animal is likely to detract from the spectacle of the Show ring.
5. Health certificates issued by the Society's Veterinarian will take precedence over health certificates issued by exhibitor's veterinarians.

PESTIVIRUS

All cattle will be required to be tested for Pestivirus and certified as non-PI (persistently infected). Exhibitors must complete question 3a on the National Cattle Health Declaration stating this testing complete. Copies of test results must be submitted prior to arrival. EMAI laboratories provide PI-test® using hair samples, visit <http://www.dpi.nsw.gov.au/about-us/services/laboratory-services/veterinary/pestivirus-infection-cattle> for sample kits, pricing, turnaround times & veterinary specimen advice forms. Swans Veterinary Services provide PI-test® using ear notch testing, visit <http://www.swansvet.com> for kits, pricing, turnaround times and forms.

Please Note: Pesti testing is a once off lifetime certification.

EXHIBITION DAIRY

DAIRY COMPLEX

The Society and the Dairy Authority of South Australia have combined to provide a 12 unit Dairy complex licensed by the Metropolitan Milk Board to be situated in the north-west corner of Pavilion 13.

All cows will be required to be milked in this complex unless special circumstances are approved by the Dairy Cattle Committee. The complex will be open for milking from 3.00 pm on Thursday 29 August and will close for cleaning twice per day. Exhibitors will be notified during the Show.

RULES & REGULATIONS

- Any animal which has been treated and/or its milk is not fit for human consumption must have a signed Treatment Report Form completed by the exhibitor/handler and given to the Dairy Manager prior to milking. This is included in the National Code of Ethics.
- No use of portable milking machines except at the discretion of the Dairy Cattle & Pig Committee.
- Dairy Managers will co-ordinate all operations in the Dairy.
- Individual cows will be identified by RA&HS Exhibit Numbers which will be written on leg-bands supplied by the Dairy Management.
- Leg bands with cow exhibit numbers must be on all cows prior to entry in milking dairy.
- Infectious or problem-milk cows MUST be milked on either of the two units outside the Exhibition Dairy.
- Cows with milk unfit for consumption and are infectious to be milked on red side.
- Cows with milk unfit for consumption but not infectious to be milked outside on Blue Side (non infectious).
- Cows may be individually sampled and tested for components, cell count and antibiotic residues.
- Proceeds from milk may be credited to exhibitors at the discretion of the Society.
- Treatment of cow's teats and udders during milking must be such that contamination of milk is avoided and disease spread is minimised. It is preferable that teats are sprayed with iodine based solution after milking.
- Exhibitors are encouraged to pre-spray and wipe clean udders before attaching milking machine to cows. Note: it is ideal to allow a contact time of one minute as a minimum before wiping with clean paper towel.
- Rugs must be off cattle at all milkings
- Dress – ALL PEOPLE WORKING IN THE PIT MUST BE PROPERLY ATTIRED.
- All people in the pit must also wear an apron during afternoon milking. Thongs or bare feet are not allowed under any circumstances. The suitability of attire worn must ensure the appropriate image is presented for the benefit of the Society and Dairy Industry.
- The dairy will close for an hour twice daily after morning and evening milking for cleaning. Times will be advised to exhibitors and the dairy will not be available for milking during those times.
- Exhibitors are reminded that they should leave the dairy clean after use if not during a normal milking time. Cleaning of the milking machine will be by dairy staff but hosing out of the dairy is encouraged. The milking machine should not be left running if no cows are being milked.
- Dairy will close at the discretion of the Dairy Manager.
- Order of milking will be determined by Dairy Management.
- If an exhibitor misses their allocated milking time, they will be rescheduled to follow the last scheduled group for that milking.
- Disputes will be referred to the Dairy Manager and will be resolved by the Dairy Cattle & Pig Committee.
- No cow treatments should be administered in the dairy, this means injections and udder infusions, the use of teat sprays and udder creams is acceptable.
- The consumption of alcohol and drugs and smoking is banned in and near the dairy.

COSTS AND DISPOSAL OF CONTAMINATED MILK

As this complex is a registered dairy the same conditions apply as with on-farm dairies –

ie any exhibitors who supply milk that contaminates a bulk tank or a tanker load of milk will be held financially responsible for:

- The cost of collection and transport of the milk to the processing factory, including a replacement load of market milk.
- Value of the milk lost due to contamination.
- Cost of disposing of the contaminated milk.

Disposal costs will vary and producers will be given the option of disposing of the milk on their own properties. Contaminated milk is considered to be any milk containing antibiotic, colostrum, blood or strong taint or smell.

PRODUCTION CLASSES

It is the responsibility of the exhibitor to provide production certificates. All production certificates to be handed to the Dairy Cattle Supervisor's Office by 12:00 noon on Sunday 1 September.

In type and production and all other classes requiring production qualifications, production figures obtained at official tests, and by recorder sampling and owner sampling will be accepted.

Calculations for the type and production class are to be calculated on one (1) point for each five (5) kilograms of fat and protein over the following standard for age figures.

- J 2 year old 240 kg protein and fat
- S 2 year old 260 kg protein and fat
- J 3 year old 280 kg protein and fat
- S 3 year old 290 kg protein and fat
- J 4 year old 300 kg protein and fat
- S 4 year old 310 kg protein and fat
- M 320 kg protein and fat

In the case of a draw, a 75% ratio factor will be introduced to decide the winner.

ROYAL ADELAIDE SHOW - EXHIBITORS CONDITIONS OF ENTRY

HAZARD REPORTING

Exhibitors must notify the Area/Pavilion Supervisor or the Venue Control Centre immediately of any hazards detected. Hazards are any situation which has the potential to cause:

1. Injury, illness or death to people or animals either immediately or in the future
2. Damage or destruction to property

INCIDENT REPORTING

Exhibitors must notify the Area/Pavilion Supervisor or the Venue Management Office immediately an incident occurs which has resulted in:

1. The injury, illness or death of any person or animal
2. The damage, destruction or loss of property
3. A near miss incident that could have resulted in the consequences listed in 1 and 2

WASTE DISPOSAL

All waste including liquids must be disposed of responsibly and placed in the appropriate bin or receptacle. Storm drains must not be used for the disposal of any waste.

HAZARD MINIMISATION

All areas must be kept in a clean and tidy order with clearly defined and available access and exit routes at all times. Build-up of combustible waste must be avoided.

Care must be taken to minimise trip hazards and obstacles that people may walk into.

HAZARDOUS MATERIALS

The RA&HS are to be advised of all hazardous materials that are brought onto the Showground. Appropriate warning signs and Safety Data Sheets (SDS) will need to be provided before allowing these materials on site. SDS are to be available onsite and provided immediately upon request by an RA&HS Representative.

MEDIA COMMENTS

Any public comment on emergencies, incidents or other venue matters should only come from the RA&HS. The key media spokesperson for the RA&HS is the Marketing Manager.

DUTY OF CARE

It is important to ensure your own safety and that of all other site personnel, visitors and general public at the Adelaide Showground.

All competitors have a "Duty of Care" to avoid exposing themselves or other people to situations which could lead to injury. This "Duty of Care" extends to the prevention of damage to property.

LIABILITY AND INDEMNITY

1. Release

- Entry to and remaining on the Showground is entirely at the risk of the Exhibitor and to the maximum extent permitted by law, the Exhibitor releases the Society (which term includes in this clause the Society's officers, employees, members and agents), from all claims and demands of every kind resulting from any accident, damage or injury occurring at the Showground, and without limitation, the Exhibitor acknowledges:
 - the Society has no responsibility or liability for any loss, damage or injury to or caused by any Exhibit;
 - the Society has no responsibility or liability for any loss, damage or injury to or caused by any Exhibit, his or her family, invitees and Agents;
 - the Society has no responsibility or liability for any loss, damage or injury to a Motor Vehicle or any of its contents whilst it is located on the Showground; and
 - without limiting Regulations 1 (a) and 1 (b) above, the Society has no responsibility or liability for any loss, damage or injury resulting from the sale, treatment, failure to treat, destruction, disposal or other dealing with any Exhibit, or for loss, damage or injury to any personal belongings, equipment or property brought onto the Showground.

2. Indemnity

To the maximum extent permitted by law, the Exhibitor must indemnify and keep indemnified the Society and its officers,

employees, members and agents from and against all actions, claims, demands, losses, damages, costs, expenses and liabilities including without limitation, consequential loss and loss of profits for which the Society is or may be or become liable in respect of or arising from:

- a) loss, damage or injury to any person in connection with the Exhibit or the relevant Event;
- b) without limiting Regulation 2(a), loss, damage or injury to any other Exhibit or Exhibitor, his or her family, invitees, Agents, or to the property of the Society, or its members, or to the general public, caused or contributed to or by any act or omission of an Exhibit of the Exhibitor or by the Exhibitor, his or her family, invitees or Agents; and
- c) without limiting Regulation 2(a), loss, damage or injury to the Exhibit, or the Exhibitor, his or her family, invitees, or Agents caused or contributed by an act or omission of an Exhibit of the Exhibitor or by the transportation, feeding or housing of an Exhibit of the Exhibitor.

3. Removal from Showground

Without prejudice to any other provision in these Regulations, where the Society, its officers, employees, members or agents removes an Exhibit, or causes an Exhibit to be removed from the Showground, the Exhibit is removed or caused to be removed entirely at the risk of the Exhibitor. The person or persons removing the Exhibit will be deemed to be the agent of the Exhibitor, and his or her acts and omissions will be deemed to be the acts and omissions of the Exhibitor.

4. Insurance

The Society will arrange Animal Exhibitors Public Liability insurance cover for all Exhibitors of Exhibits being animals. The Exhibitor is bound by the terms and conditions of this insurance and by Statutory Duties as defined under the Insurance Contracts Act (1984). Details of the Animal Exhibitors Public Liability insurance are set out in the Relevant Schedule. The Society does not insure first party loss, damage or injury to Exhibits, and Exhibitors should consider purchasing insurance if required.

5. Personal effects

The Society has no responsibility or liability for any loss or damage caused to personal belongings, equipment or property which is brought onto the Showground by an Exhibitor, his or her family, invitees or Agents.

EMERGENCY INFORMATION

Emergency information and Emergency Assembly Points for the various animal pavilions and stables will be included with Exhibitor List of Entries and Notice to Exhibitor notifications. Competitors should be familiar with these plans.

FIRST AID

During the Royal Adelaide Show, St John provides First Aid Services but it is suggested that competitors have a basic First Aid kit for minor medical requirements.

St John is not in attendance after public hours.

For emergency contact details, check Notice Boards for onsite assistance or dial 000 for a medical emergency.

RA&HS EMERGENCY FACILITIES

Firefighting and other emergency equipment must not be removed or used for any other purpose. Missing or unserviceable equipment should be reported to the Venue Control Centre immediately.

SMOKING

Smoking is only permitted in designated locations. The Royal Adelaide Show is a smoke free event.

TRAFFIC CONTROL

The RA&HS Traffic Control Policy imposes speed restrictions within the Showground. For the duration of the Royal Adelaide Show the speed limit is 10 kph on the grounds and 8 kph inside buildings.

The use of vehicles inside the Showground is closely managed during the Royal Adelaide Show. Conditions of entry will be provided with the issue of Vehicle Entry Permits.
